## Gambling Community Benefit Fund (GCBF)

Purpose: The GCBF funding helps community groups to provide services, leisure activities and opportunities for Queensland communities. Amount: \$100,000

 $Funding \ Provider: \ Queensland \ Government-Department \ of \ Justice \ and \ Attorney-General$ 

#### Closing Date: 28 February 2024

The Gambling Community Benefit Fund (GCBF) is Queensland's largest one-off community grants program and distributes approximately \$60 million each year to not-for-profit community groups.

### Indigenous Visual Arts Industry Support Program (IVAIS)

Purpose: The IVAIS Program helps fund the operations of more than 85 Indigenous-owned art centres, and a number of art fairs, regional hubs and industry service organisations that are at the heart of Australia's world-famous Indigenous visual art movement. Amount: \$5,000 to \$80,000 Funding Provider: Department of Infrastructure, Transport, Regional Development,

Closing Date: 18 February 2024 11:30pm (ACT Local Time)

The grant provides funding to organisations for activities that best contribute to delivery of the following Program outcomes:

- 1. A professional, viable and ethical Indigenous visual arts industry that features strong participation and provides economic opportunities for Aboriginal and Torres Strait Islander people.
- 2. The continued production, exhibition, critique, purchase and collection of Indigenous visual art.

### Eligibility

To be eligible for an IVAIS grant, your organisation must be one of the following entity types:

- An Aboriginal and/or Torres Strait Islander Corporation registered under the *Corporations* (Aboriginal and Torres Strait Islander) Act 2006
- An entity established through specific Commonwealth or State or Territory legislation
- A company incorporated in Australia
- A company limited by guarantee
- An incorporated association

- A publicly funded research organization
- State, Territory or local government body

And

- Have an Australian Business Number (ABN)
- Be registered for the Goods and Services Tax, if required by the Australian Tax Office
- Have no overdue acquittals or serious breaches relating to Australian Government funding. A serious breach is one that has resulted in, or warrants, the termination of a grant agreement.

# Community-led Men's Wellness Centres for Aboriginal and Torres Strait Islander Peoples

Purpose: The Australian Government is inviting organisations via a restricted process to apply to deliver services under the program from 2023–24 to 2026–27. Amount: undisclosed Funding Provider: Department of Social Services Closing Date: 16 February 2024 9:00pm (ACT Local Time)

Community-led Men's Wellness Centres for Aboriginal and Torres Strait Islander peoples is a program to establish Men's Wellness Centres in suitable locations. It includes activities such as prosocial early support, cultural healing and education on respectful relationships, healthy parenting, mentoring, living skills and alcohol and other drugs, and understanding diverse experiences of abuse such as technology facilitated abuse and coercive control.

This program is a measure in the Commonwealth Implementation Plan under the National Agreement on Closing the Gap (Closing the Gap) to achieve Target 13: *By 2031, the rate of all forms of family violence and abuse against Aboriginal and Torres Strait Islander women and children is reduced at least by 50%, as progress towards zero.* 

Activities under this program will be designed, led, delivered and evaluated by Aboriginal and Torres Strait Islander organisations, to empower Aboriginal and Torres Strait Islander peoples to share decision-making authority with governments and contribute to building the Aboriginal Community Controlled sector.

Purpose: The Australian Government is inviting organisations via a restricted process to apply to deliver services under the program from 2023–24 to 2025–26. Amount: undisclosed Funding Provider: Department of Social Services Closing Date: 16 February 2024 9:00pm (ACT Local Time)

Increasing Capacity of Crisis Accommodation Services for Aboriginal and Torres Strait Islander Peoples is a program funding to support urgent attention to increase the capacity of Aboriginal and Torres Strait Islander shelter and accommodation services, especially in regional and remote areas.

The program is designed to centre Aboriginal and Torres Strait Islander cultural knowledge, frameworks and responses in the way that services are designed and delivered to better meet the needs of Aboriginal and Torres Strait Islander peoples with multiple and complex needs.

This program is a measure in the Commonwealth Implementation Plan under the National Agreement on Closing the Gap (Closing the Gap) to achieve Target 13: *By 2031, the rate of all forms of family violence and abuse against Aboriginal and Torres Strait Islander women and children is reduced at least by 50%, as progress towards zero.* 

Activities under this program will be designed, led, delivered and evaluated by Aboriginal and Torres Strait Islander organisations, to empower Aboriginal and Torres Strait Islander peoples to share decision-making authority with governments and contribute to building the Aboriginal Community Controlled sector.

Purpose: The Australian Government is inviting organisations via a restricted process to apply to deliver services under the program from 2023–24 to 2026–27. Amount: undisclosed Funding Provider: Department of Social Services Closing Date: 16 February 2024 9:00pm (ACT Local Time) Family Domestic and Sexual Violence Programs in Aboriginal and Torres Strait Islander Community-Controlled Organisations is a program funding Aboriginal and Torres Strait Islander Community-Controlled Organisations to meet existing demand for family, domestic and sexual violence services.

This program is a measure in the Commonwealth Implementation Plan under the National Agreement on Closing the Gap (Closing the Gap) to achieve Target 13: *By 2031, the rate of all forms of family violence and abuse against Aboriginal and Torres Strait Islander women and children is reduced at least by 50%, as progress towards zero.* 

Activities under this program will be designed, led, delivered and evaluated by Aboriginal and Torres Strait Islander organisations, to empower Aboriginal and Torres Strait Islander peoples to share decision-making authority with governments and contribute to building the Aboriginal Community Controlled sector.

# Community-led Prevention Services, Programs and Campaigns for Aboriginal and Torres Strait Islander Children

Purpose: The Australian Government is inviting organisations via a restricted process to apply to deliver services under the program from 2023–24 to 2025–26. Amount: undisclosed Funding Provider: Department of Social Services Closing Date: 16 February 2024 9:00pm (ACT Local Time)

Community-led Prevention Services, Programs and Campaigns for Aboriginal and Torres Strait Islander Children is a program funding prevention services, programs and campaigns for Aboriginal and Torres Strait Islander children, including on-Country learning.

To break the cycle of violence, Aboriginal and Torres Strait Islander children and young people must be provided with opportunities to heal from their experiences of violence, and to address their own use of problematic and harmful family, domestic or sexual behaviours in holistic ways that incorporate values from culture that drive behaviour change.

This program is a measure in the Commonwealth Implementation Plan under the National Agreement on Closing the Gap (Closing the Gap) to achieve Target 13: *By 2031, the rate of all forms of family violence and abuse against Aboriginal and Torres Strait Islander women and children is reduced at least by 50%, as progress towards zero.* 

Activities under this program will be designed, led, delivered and evaluated by Aboriginal and Torres Strait Islander organisations, to empower Aboriginal and Torres Strait Islander peoples to share decision-making authority with governments and contribute to building the Aboriginal Community Controlled sector.

To be eligible you must be one of the following entity types:

• Indigenous Corporation

- Company
- Cooperative
- Incorporated Association
- Corporate State or Territory Entity
- Partnership
- A Trust .

### Saluting Their Service (STS) Commemorative Grants Program

Purpose: The Saluting Their Service (STS) Commemorative Grants Program is designed to commemorate the service and sacrifice of Australia's service personnel in wars, conflicts and peace operations, and their families. Amount: \$10,000 to \$150,000 Funding Provider: Department of Veterans' Affairs and Defence Personnel Closing Date: 6 February 2024 9:00pm (ACT Local Time)

The intended outcome of the grant opportunity is to provide funding for projects and activities that:

- promote appreciation and understanding of the experiences of service and the roles that those who serve have played
- preserve, add to the sum of knowledge on, or provide access to information about Australia's wartime heritage.

The STS Program provides funding for one-off projects that are ready to proceed and where the funding will ensure their completion. Projects must be able to be completed within 12 months of the funding agreement being executed.

Two categories of grants are available under the STS program:

### Community Grants (CG)

Grants to a maximum of \$10,000 are available for community-based commemorative projects and activities.

These small grants are for projects and activities that are focused on the local community, commemorate the service and sacrifice of local community members, and are primarily accessed by the local community.

Some examples of CG projects and activities include:

- development of an Honour Roll
- restoration of an existing local War Memorial
- supply and installation of a cabinet to display military memorabilia
- installation of flagpoles

#### Major Grants (MG)

Grants between \$10,001 and \$150,000 are available for major commemorative projects and activities that are significant from a national, state, territory and/or regional perspective.

MG grants will have a much wider focus than CG category applications and must be commemorative of the service and sacrifice of service personnel beyond the local community, and/or consist of elements that are available to the whole nation, or residents of a state, territory, or regional area.

If your project has a high monetary value, it does not necessarily mean that it is considered an MG.

Some examples of MG projects and activities include:

- construction of an interactive memorial walking track dedicated to all Australian service personnel from the Vietnam War
- development of a digital honour roll and interpretive signage to commemorate the history of service personnel from a particular region
- development of a documentary commemorating Australian Prisoners of War

### Australian Cultural Diplomacy Grants Program (ACDGP)

Purpose: The ACDGP 2023-24 Round will support projects that promote Australia's creative sector and First Nations identity to deepen bilateral partnerships and strengthen our reputation as a modern diverse nation internationally. Amount: up to \$10,000 to \$60,000 Funding Provider: Department of Foreign Affairs and Trade Closing Date: 12 February 2024 4:00pm (ACT Local Time)

The objectives of the grant opportunity are to:

- support the promotion of Australia's creative sector internationally
- support collaborative and innovative projects that promote Australia as a modern, diverse nation and a source of creative excellence
- influence perceptions of Australia at home and abroad through building cultural understanding and connections
- build people-to-people and /or institutional links internationally

- support First Nations creative industries and seek opportunities to assist in embedding First Nations into our Foreign Policy
- align with 'Revive', Australia's National Cultural Policy.

The intended outcomes of the grant opportunity are to:

- increase public awareness of Australia's, artistic and cultural assets in the host countries
- develop enduring partnerships in the creative sector particularly with First Nations focus in the bilateral, regional and global context between Australian organisations/individuals and those in the host countries
- increase Australia's capacity to effectively engage with the host countries, especially in the arts and creative sectors to support ongoing collaboration.

To be eligible, you must have an Australian Business Number (ABN), be registered for GST, be an Australian citizen or a permanent resident of Australia.

### **National Justice Reinvestment Program – Round 2**

Purpose: The Australian Government is inviting applications through an open noncompetitive process to deliver justice reinvestment initiatives. Amount: undisclosed Funding Provider: Attorney-General's Department Closing Date: 10 September 2024 9:00pm (ACT Local Time)

The objective of this grant opportunity is to:

- support the development and delivery of community and Aboriginal and Torres Strait Islander-led justice reinvestment initiatives across Australia, by supporting:
  - the development, implementation, and evaluation of local justice reinvestment strategies and activities
  - local project teams and leadership structures to undertake the work of developing, implementing and evaluating justice reinvestment strategies.

The intended outcomes of this grant opportunity are:

- Improving justice outcomes and reducing contact with the criminal justice system and incarceration of Aboriginal and Torres Strait Islander adults and young people, in line with Closing the Gap Targets 10 and 11.
- Contributing to systemic reform of government systems that intersect with the justice system.

• Contributing to building a strong and sustainable Aboriginal and Torres Strait Islander community-controlled sector delivering high quality services to meet the needs of Aboriginal and Torres Strait Islander people across the country.

Applications will be assessed in 2 cycles:

- Assessment cycle 1 opens 5 January 2024 to 9 May 2024.
- Assessment cycle 2 opens 9 May 2024 to 10 September 2024.

**Eligibility:** You must demonstrate how you will centre your work on the needs of Aboriginal and Torres Strait Islander people living in your community, including by demonstrating you have support and authority to lead or act as the coordinating body for this work within a community, and that the work will be delivered in partnership with community members.

### **Commonwealth Teaching Scholarships**

Purpose: Commonwealth Teaching Scholarships deliver on Action 2 under the National Teacher Workforce Action Plan to help attract high quality candidates into the teaching profession and to help address teacher workforce shortages. Amount: up to \$40,000 per student Funding Provider: Department of Education Closing Date: 14 January 2024

Commonwealth Teaching Scholarships support new undergraduate and postgraduate teaching students to meet the costs of their study in exchange for teaching in government schools or government-run early learning settings for a period of time after graduating from their degree.

Scholarships of up to \$40,000 per student are available for full-time undergraduate initial teacher education (ITE) students (\$10,000 per year for a four-year qualification) and up to \$20,000 for full-time postgraduate ITE students (\$10,000 per year for a two-year qualification).

Applications are strongly encouraged from school leavers and career changers who meet the eligibility criteria and who are high-achieving students (with an ATAR of 80 or above or equivalent academic result), First Nations peoples, people for whom English is an additional language or dialect, people with disability, people from regional, rural or remote locations, mid-career professionals or people from low socio-economic backgrounds, who aspire to a rewarding career in teaching.

Scholarships will be available over five rounds from 2024 to 2028 with up to 1,000 scholarships per year to be offered.

The first round of scholarships are now open for students commencing ITE programs in the first semester/study period of 2024.

To apply, you must be a person living in Australia who is:

- An Australian citizen
- A permanent resident
- A holder of a permanent humanitarian visa; or
- A New Zealand citizen living in Australia

### Foundation for Rural and Regional Renewal's (FRRR) Strengthening Rural Communities (SRC) Program (SRC)

Purpose: The SRC Rebuilding Regional Communities (RRC) stream gives small remote, rural and regional communities across Australia the opportunity to access funds for a broad range of initiatives that directly and clearly benefit local communities. Amount: up to \$10,000 Funding Provider: Australian Government Closing Date: 26 February 2024 5:00pm AEDT

The Foundation for Rural & Regional Renewal's (FRRR) Strengthening Rural Communities program provides grants of up to \$10,000 to support local organisations to uplift their communities following significant disruption from COVID-19.

Grants could be for initiatives such as workshops, education programs or improving facilities and community equipment.

This is the final round of the Rebuilding Regional Communities stream.

### **Industry Growth Program**

Purpose: The program supports innovative small and medium enterprises undertaking commercialisation and/or growth projects within the National Reconstruction Fund priority areas through advisory services and opportunities for matched grant funding. Minor changes or improvements to existing products or services are not considered innovative. Amount: \$50,000 to \$250,000 to support early-stage commercialization projects; \$100,000 to \$5 million for commercialisation and growth projects Funding Provider: Australian Government Closing Date: None

The \$392 million Industry Growth Program provides grants and advice to help small and medium enterprise (SME) businesses commercialise their ideas and expand.

Small-to-medium businesses and start ups can now apply under the Industry Growth Program to receive advice from industry experts.

Advice will come from industry experts who have been either founders of companies or commercialisation experts in previous roles.

Grants between \$50,000 and \$5 million will open in the new year. Businesses can apply for a grant after they receive a service report from their adviser.

# Workforce Incentive Program – Rural Advanced Skills Incentive

Purpose: The Rural Advanced Skills Stream rewards investment in specialist qualifications and advanced skills and encourages more doctors to work in a variety of settings using these skills in regional, rural and remote areas. Amount: \$4,000 to \$10,500 per annum

Funding Provider: Department of Health and Aged Care Closing Date: None

The Workforce Incentive Program – Rural Advanced Skills payment aims to support access to health care in rural and remote communities (Modified Monash MM 3-7 locations). This is by providing additional annual incentive payments to doctors working in primary care and using advanced skills working across a range of other settings.

The new incentive rewards investment in specialist qualifications and credentialled skills. It encourages more doctors with these advanced skills to work in regional, rural and remote areas.

To be eligible for WIP Rural Advanced Skills payment, doctors must:

- provide comprehensive MBS primary care/general practice in MM3-7 locations
- meet minimum service thresholds (as outlined below in Section 1.3) of the <u>Program</u> <u>Guidelines</u>
- provide evidence (e.g signed supporting documentation) to substantiate their application (proof of qualifications or advanced skills and employer verification of services delivered).

See the <u>WIP Rural Advanced Skills Guidelines</u> for full details of eligibility requirements.

Available data shows that more than 2,500 doctors may be eligible to claim the payment within each stream. This is based on the number of doctors with rural generalist skills and consultation with the sector during program design work.

## **Education**

### Schools Upgrade Fund Round 2

Purpose: The purpose of the Schools Upgrade Fund (SUF) is to provide more equitable access to resources to support state schools to help keep students and school staff safe, and get students' education back on track after disruptions caused by COVID-19. Amount: Funding Provider: Department of Education

Closing Date: 29 February 2024 11:59pm AEDT

The SUF Round 2 will support government schools invest in larger-scale capital fund projects, such as new classrooms, building refurbishments, outdoor learning spaces or major upgrades. A minimum of \$250,000 (GST exclusive) of funding must be committed to each project.

Round 2 funding will be needs based, prioritising schools experiencing the greatest disadvantage. Project funding will prioritise:

- projects that support schools with a low Index of Community Socio-educational Advantage (ICSEA) value
- eligible projects for disadvantaged schools that have not received significant capital funding in the past two years (that is, projects valued at \$250,000 or more in 2022 or 2023).
- projects that support schools that cater to disadvantaged students, such as:
  - special schools
  - special assistance schools or
  - majority Aboriginal and Torres Strait Islander schools.

The Schools Upgrade Fund Round 2 Government School <u>Guidelines</u> provide more information on eligible projects and should be read carefully before applying.

Schools are encouraged to consult with their relevant state or territory education department early to seek their assistance with project scoping and costing.

Schools must have the support of their state or territory education department to apply for funding under Round 2.

## **Environment**

### **Urban Rivers and Catchments Program Round 2**

Purpose: The Program will fund small-medium projects from \$150,000 to \$2 million and large-scale projects with grants from \$2 million to \$10 million to conserve native and threatened species and improve the ecological health of urban waterways. Amount: \$150,000 to \$2 million; \$2 million to \$10 million Funding Provider: Department of Climate Change, Energy, the Environment and Water Closing Date: 13 February 2024 5:00pm AEDT

The Urban Rivers and Catchments Program comprises 2 rounds.

Round one projects will be delivered through specific purpose payments to the states and territories.

Round two projects will be competitive grants, contracted with successful grant recipients.

### **Round Two**

The May 2023-24 Budget provided funding through the Natural Heritage Trust for a competitive grants round under the Urban Rivers and Catchments Program.

\$109 million (from 2024-25) is available for project grants under the opportunity. It is expected this will fund around 100 projects that bring life back to our rivers, creeks, wetlands, and waterways in urban, outer urban and regional centres.

There are two distinct grant opportunities:

- Stream one small to medium-sized project grants of between \$150,000 to \$2 million for community-led projects. A total of \$51 million is available under this stream.
- Stream two large scale project grants of between \$2 million to \$10 million for projects that include co-investment. A total of \$58 million is available under this stream.

### **Community Energy Upgrades Fund Round 1**

Purpose: The Community Energy Upgrades Fund will deliver \$100 million over 2 funding rounds and will run over 3 years from 2024-25. The program will co-fund energy efficiency and electrification upgrades for local governments to deliver reduced energy bills and emissions from local government owned and/or operated facilities. The program will contribute to Australia meeting its emission reduction targets of 43% by 2030, net zero emissions by 2050, and support 82% renewable electricity generation by 2030. It will also support the Commonwealth-led National Energy Performance Strategy (NEPS). Amount: \$25,000 to \$2.5 million

Funding Provider: Department of Climate Change, Energy, the Environment and Water

### Closing Date: 30 April 2024 5:00pm (ACT Local Time)

The objectives of the program are to support:

- the Government's broader efforts to reduce emissions and improve energy performance and contribute to Australia meeting its emission reduction targets of 43 percent by 2030, Net-Zero emissions by 2050 and 82% renewable electricity generation by 2030
- local governments to decarbonise their operations and reduce energy bills through energy efficiency and load flexibility upgrades and electrification of their facilities
- the improvement in energy performance necessary to utilise renewable electricity more easily and improve system reliability.

The intended outcomes of the program are:

- reduced energy bills and emissions from local government owned and/or operated facilities
- installed energy efficiency, load flexibility and electrification technology that is commercially available
- improved capability of local governments and the wider community to implement energy upgrades and electrification projects in their facilities
- increased capacity of domestic supply chains and labour force to support significant future investment in energy efficiency upgrades
- improved workforce skills in delivering and operating energy transition projects.

### Eligibility

You can apply if you

• have an Australian Business Number (ABN)

and are one of the following entities:

- a Local Government Body
- a Joint Local Government Body (defined in section 14 of the grant opportunity guidelines)

## <u>Health</u>

## Aged Care Capital Assistance Program

Purpose: The program aims to maintain or increase access to quality aged care services in thin market settings for people: from First Nations communities; living in regional, rural, and remote areas; who are homeless, or at risk of becoming homeless; or with other complex and diverse needs, including dementia. Amount: \$135 million (in total) Funding Provider: Department of Health and Aged Care

Closing Date: 12 January 2024 2:00pm (ACT Local Time)

This grant opportunity will provide grant funding for infrastructure projects across four funding streams which are primarily focussed on maintaining or improving access to quality aged care services in small rural towns, remote and very remote communities and will also support specific groups of older Australians, including people who are homeless or at risk of homelessness and First Nations communities.

Each stream has specified objectives and outcomes that need to be considered when applying.

For this grant opportunity up to a combined **\$135 million** is available across the four Streams, comprising:

- **\$95 million** combined across both:
  - Stream 1 Staff Accommodation, and
  - Stream 2 Upgrades, Expansions or New Builds.
- **\$30 million** in Stream 3 Specialised Homeless
- **\$10 million** in Stream 4 NATSIFAC Minor Projects and Equipment.

To be eligible, you must be an Australian Government approved aged care provider and one of the entity types listed in Section 4.1 of the Grant Opportunity Guidelines.

### NHMRC e-ASIA 2024 Joint Research Program
